In signing this, I acknowledge my understanding and appreciation of the inherent dangers and risks associated with the activities that I (or my minor child) will be participating in with the Caswell Ranch LLC. I am particularly cognizant of the risks and dangers associated with the use of firearms. I assume as my personal risk all the hazards of shooting activities and do hereby fully and irrevocably release and forever discharge Caswell Ranch LLC and their respective owners, officers, directors, agents, employees, successors, and assigns, from any and all claims, demands, actions, losses, and/or liability of an kind, nature or description that may be sustained by me (or my minor child).

I hereby assume as my sole personal responsibility any and all costs incurred as a result of my (or my minor child's) actions or in my (or my minor child's) behalf for rescue efforts and all medical emergencies.

RANGE POLICIES; CASWELL RANCH IS STAFFED AT ALL TIMES.

1. All visitors must check in at Welcome Center.
2. All shooters & visitors going onto the range must sign the liability waiver.
3. All shooters & spectators must wear ear & eye protection on the range.
4. All shooters & spectators will have a safety orientation.
5. No center fire rifles or BATF Class III weapons may be used on pistol bays (exception: Law Enforcement in training only).
6. No shooting after dark
7. No shooting before 10am (exception: during a championship)
8. No shooting on Sunday before 12 noon.
9. Pistol competitions: each shooter group or stage will have two certified safety officers.
10. No drugs or alcohol prior to or during a shooting session or when handling a firearm, prescription drug that may impair a shooter or spectators ability to remain safe shall be reported to the range staff.
11. NO explosive devises (exception: Law Enforcement in training only)
12. The Range is supplied with props for match stages. Props are never to be used for targets or target backer, example: stapling target to wall. Wood stand with two upright sticks are on the range and used to hold cardboard targets. Using the upright sticks for targets can result in lost membership.
